

SAP Note 199642 - ME22: ME552 / EI196 (inconsistencies in EKKO-LANDS)

Note Language: English Version: 4 Validity: Valid Since 13.06.2003

Summary

Symptom

In purchasing documents that have been created in earlier releases than Release 4.0, field EKKO-LANDS is not filled.

If such a document is edited in later releases, due to an incorrect program routine, first the field is filled with the country to which the company code of purchase order EKKO-BUKRS is assigned.(Customizing table T001, field T001W-LAND1).

The program then determines to which country the plant is assigned in the first purchase order item (EKPO-WERK) (Customizing table T001W, field T001W-LAND1).

Furthermore, it is checked whether the values match in EKKO-LANDS and T001W-LAND1. If this is not the case then, the system generates different error messages depending on the processing transaction.

These are possible error messages:

ME552 'Please choose plants from one country only per PO (Here &)'

EI196 'No import country exists; processing not possible!'

Other terms

Foreign trade, import purchase order, EKKO-LANDS, VIS1, customs, EGG 196, Plants abroad, WIP, batch input, import, foreign trade, ME552, ME22

Reason and Prerequisites

The problem is caused by a program error. It is corrected for Release 4.6C.

Solution

This note is a correction report for the elimination of existing inconsistencies. It is valid for all release statuses listed above.

Caution! The report assumes that the item number of the first item is identical with the item number interval. If this is not the case in your system, delete the following line in the report:

AND P~EBELP = K~PINCR

As a result, this report now runs for all items, however, only field EKKO-LANDS is still updated.

You can obtain the corresponding corrections for the program source code via Notes 194069 and 136704.
